- Investors who have already submitted an SPF form or already registered for SPF facility, should not submit SPF form again as SPF registration is a one-time process only for each bank account. However, such investors if wish to submit new bank accounts towards SPF facility may fill the form.
- Other investors, who have not registered for SPF facility, may fill the SPF form and submit along together with their bank mandate.
- Every investor and their bank should mandatorily provide their bank account and other bank details and mandate form, where the investor must provide a photocopy or photograph form of the form as a basis to step in the form. The bank provided on the mandate form should be correct in every way. In case of any discrepancy whatsoever, the SPF will be the account holder's responsibility.
- The SPF forms require three mandatorily and mandatory steps to be filled in:
 - a) Investor Registration Date: This date is defined as the day right after the SPF form, this will be the date that the SPF form is received by the SPF.
 - b) Period: From: Date: This is the starting date of the period for which the mandate will be submitted.
 - c) Period: To: Date: This date will be the end of the period for which the mandate is valid. The "To" date must be later than the "From" date from the Investor Registration Date.
